## **Introduction**

The Northern Ireland Guardian ad Litem Agency (NIGALA) was established by the DHSSPS in accordance with Article 60(7) of the Children (NI) Order 1995 and the Guardian ad Litem (Panels) Regulations (Northern Ireland) 1996. Article 60(1-2) of the Children (NI) Order 1995 requires the Court, in any case involving Specified proceedings (defined in Article 60(6) of the Order), to appoint a Guardian ad Litem for the child concerned unless satisfied that it is not necessary to do so. The role of the Guardian ad Litem (GAL) is to ensure the independent representation of the wishes and feelings of the child/children who are the subject of Specified Public Law proceedings under the Children (NI) Order and/or proceedings under the Adoption (NI) Order 1987 and to ensure the safeguarding and promotion of the child's wishes and best interests. NIGALA therefore has a pivotal role in ensuring that the Children (NI) Order is implemented as intended.

This document provides comparative annual statistics for the years 2016/17 and 2015/16 in relation to: case numbers by proceedings type; case duration; Court transfers; Guardian ad Litem recommendations and Court Orders granted; the age and gender of children subject to proceedings during 2016/17.

Key statistics to emerge for the year 2016/17 include:

- An increase in the number of Guardian ad Litem appointments by 13% from 709 to 798 cases;
- An increase in the number of Care Application appointments by 33% from 313 to 417 cases;
- A 9% increase in the duration of Care applications from 327 to 358 days.

All statistics are correct as reported in the Guardian Case Information System (GCIS) at 31 March 2017.

Table 1A illustrates the total number of appointments of Guardians ad Litem and the number of children involved from April 2016 to March 2017, and breaks these down by proceedings type. The total number of cases increased by 13% from 709 to 798 from the previous year, with the number of children subject to proceedings increasing by 19% from 1056 to 1060.

In Specified Public Law cases NIGALA witnessed a decrease in Care Order appointments, with an 11% decrease in 2015/16 from the previous year. 2016/17 has brought a reversal of this trend with the number of Care Order appointments increasing by 33% from 313 to 417 and the number of children subject to Care applications has increased from 538 to 718. Appointments relating to applications to Discharge or Vary Orders have increased by 23% from 55 to 68. Emergency Protection Orders have decreased in 2016/17 from 3 to 1 and Termination/Variation of Contact appointments have decreased from 2 to 1. However there has been an increase in Article 56 appointments (50%) from 24 to 37. Contact applications have increased by 40% from 27 to 38.

Step-Parent Adoption appointments have decreased by 40% from 21 to 15. There has been an 8% decrease in Placement Adoption appointments from 87 to 80, following a substantial increase of 52% in 2015/16. Freeing without Consent appointments have decreased (19%) from 55 applications in 2015/16 to 46 applications in 2016/17.

Table 1B illustrates the total number of cases allocated and children involved in 2016/17 compared with the previous year. There were a total of 808 cases allocated; an 11% increase in cases from the previous year. It included a 26% increase in Care applications. This marks a change from the previous year where the number of allocated cases had decreased from 733 cases in 2014/15 to 724 in 2015/16.

Table 2A illustrates the number of cases completed during 2016/17 compared with 2015/16 and indicates a 1% from 707 to 718 cases. This increase is the result of a higher number of Multiple proceedings, Residence Orders and a substantial increase (40%) in Placement Adoption cases completed.

Table 3 details the number of appointments of Guardians as a result of applications made by Trusts, Adoption Agencies and individuals within the respective Trust areas, as well as the number of children subject to these proceedings. There has been a 19% decrease in the number of Adoption proceedings from 173 to 145 cases. The Western Trust accounted for the majority of cases (32) followed by the Northern Trust (31) and the Belfast Trust (31) and the South Eastern Trust (28) in 2016/17. This marks a change from the previous year where the Northern Trust accounted for the majority of cases (60), followed by the Belfast Trust (34), the South Eastern Trust (27), the Southern Trust (26) and the Western Trust (21).

In the Non-Adoption proceedings there has been a 22% increase from 536 to 653 cases. The Northern Trust instigated the largest increase of applications (57%) from 89 applications in 2015/16 to 140 applications in 2016/17. The Western Trust had an increase of 29%, the Belfast Trust had an increase of 19%, the South Eastern had an increase of 18%, while the Southern Trust had a decrease of 6%. The Belfast Trust had the largest number of Public Law proceedings applications in 2016/17 - 173, an increase of 19% from the previous year of 145.

## Adoption

Table 4 indicates that in the period 1 April 2016 to 31 March 2017 there were a total of 145 appointments of Guardians in the field of Adoption; a decrease of 19% over the same period last year. The majority of Adoption/Freeing appointments came from the Belfast Family Care Centre (65 appointments) and the Royal Courts of Justice (30 appointments).

## Care Proceedings

With respect to the Care proceedings group (which includes applications for Care, Supervisions, Contact and Freeing Consolidated), there were a total of 577 appointments in 2016/17; an increase of 25% from the previous year. This marks a reversal of the trend identified the previous year which saw a decrease of 11% in cases. Outside of Belfast, the busiest Courts in terms of Care proceedings are Newtownards, Ballymena, Craigavon, Londonderry and Dungannon.

Table 5 records the range and duration of cases before the Courts in Northern Ireland from the date of notification of Court appointment of the Guardian ad Litem, to the date of Final Hearing and the discharge of the Guardian. Up until 2014/15 an increase in the duration of Care application cases under Article 50 had been a concern for all involved in these cases.

However there was a small decrease in the average number of days in 2014/15 (8%) and in 2015/16 (5%) required for Care application cases. In contrast there has been a 9% increase in the average number of days (358) required for Care application cases in 2016/17.

While there was a 14% decrease in the average duration of Placement Adoptions from 172 days in 2015/16 to 151 days in 2016/17, there was a 42% increase in the average duration of Relative Adoptions from 162 days to 230 days.

2016/17 saw a substantial decrease in the average duration of supervision applications from 374 days to 163 days (129%). Freeing without Consent has decreased in average duration by 26% decreasing from 223 days to 177 days. There has been a 19% increase in the average duration of Appeal applications in 2016/17 from 91 days to 108 days.

Table 7 indicates the number of Court Orders granted and Guardian ad Litem recommendations on each child in Adoption and Specified Public Law cases. It does not chart the changes influenced by the Guardian during the progress of the case before the Court either generally in terms of service to the child or specifically within the context of the Care Plan.

Across Adoption cases and Care proceedings there was a very high correlation between the Guardian's recommendations and the final Order made. In Adoption cases the main application was Adoption Placement in which there was a 100% correlation between the Guardian's recommendation and the final Order made. There were 123 Adoption Placement Orders and 22 Adoption Step Parents. Within Care proceedings the main application was for a Care Order, Guardians recommended a Care Order in 364 cases and the Court granted 347. With regard to Article 56 Orders, Guardians recommended No Order in 23 cases and Courts granted 16 in final outcomes.

There is agreement where Guardians recommended the Contact application being dismissed in 10 cases and the Court granted 10 dismissals. However Guardians recommended a Contact Order in 29 cases and the Court granted 34 Orders. Guardians recommended the Contact application being withdrawn in 8 cases and the Court granted withdrawals in 13 cases. There was a high correlation between the Guardian's recommendation that the Order should remain and the final Order made in Discharge/Variation of Care cases, where the Guardians recommended the Order to remain in 27 cases and the Court granted 25.

In 45 cases Guardians recommended Discharge/Variation of Order and the Court granted 45. There was a 100% correlation between the Guardian's recommendation and the final outcome of the Court in both Supervision Order cases (11 cases) and in Multiple proceedings (12 cases) where the Orders were recommended and granted.

Table 8 breaks down statistics with regard to all proceedings by way of age and gender. In 2012/13 NIGALA saw a reversal from the trend of the previous four years when there were more females than males who were subject to proceedings. This reversal to the more traditional position where slightly more males than females have been subject to proceedings continued in 2013/14, 2014/15, 2015/16 and 2016/17. These figures also continue a trend identified in the previous two years where children aged between one and five represented the majority (380), followed by five to nine year olds (355). Ten to fifteen year olds are also in the majority (322) in 2016/17. The number in the one to four age category has increased by 5% from the previous year and there has been a large increase (44%) in children aged between five and nine in 2016/17 from 246 to 355 children. What is notable is the 53% increase in the numbers of ten to fifteen years olds 2016/17 from 210 to 322.
